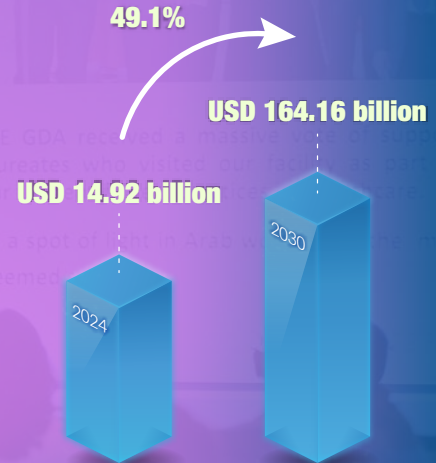
Research & Markets: The global Artificial Intelligence (AI) in healthcare market is projected to reach **USD 164.16 billion by 2030** from **USD 14.92 billion in 2024**, at a CAGR of 49.1% during the forecast period.

Careful Online: projects the AI in healthcare market to grow to an estimated **\$148.4 billion by 2029**, with a compound annual growth rate (CAGR) of 48.1%.

Philips: reports that **85% of healthcare leaders** worldwide are already investing or plan to **invest in generative AI** within the next three years, 1 with expectations of accelerated growth in 2025.

PwC forecasts that AI could contribute **US\$320 billion to Middle East economies by 2030**, with healthcare being a key sector for AI-driven advancements.

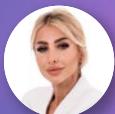

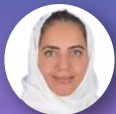

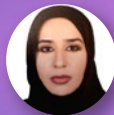
