RECIPIENTS AND PERSONAL DATA

Your personal data may be processed by third parties that provide instrumental services, including communication services, e- mail, postal mail services, technical services for the management of the Site and IT service providers.

We will communicate only the data that are strictly necessary for the aforementioned purposes. YOUR RIGHTS

In relation to the processing of personal data by Lanificio dell'Olivo S.p.a., you can request access to your data, their correction, the deletion, the integration of incomplete data, the limitation of processing. You can ask to receive data in a structured, commonly used and machine-readable format as well as, if technically possible, to transmit them to another data controller without hindrance if there are the conditions for the exercise of the right to portability contemplated in art. 20 of the GDPR (e.g. the processing is based on consent pursuant to art. 6.1 lett. a) or art. 9.2, lett. a) or on contract pursuant to art. 6.1, lett. b) of the GDPR and is carried out with automated means). You can at any time withdraw the consent given for the purposes described above and object to the processing, in whole or in part, in the cases allowed; you can lodge a complaint with the Supervisory Authority and exercise all the other rights recognized by the applicable discipline (art. 16-21 GDPR).
