

Politically Exposed Persons Declaration *(To be completed by each Director, Shareholder and UBO)*

We are required to enquire whether you are a Politically Exposed Person (“PEP”) based on the following definition:

PEP’s are natural persons who are or have been entrusted with prominent public functions and include their immediate family members or persons known to be close associates of such persons, but do not include middle ranking or more junior officials.

For the purposes of the definition of ‘politically exposed persons’:

(a) The term ‘natural persons who are or have been entrusted with prominent public functions’ shall include the following:

- i. Heads of State, Heads of Government, Ministers and Deputy and Assistant Ministers and Parliamentary Secretaries;
- ii. Members of Parliament;
- iii. Members of the Courts or of other high-level judicial bodies whose decisions are not subject to further appeal, except in exceptional circumstances;
- iv. Members of courts of auditors, Audit Committees or of the boards of central banks;
- v. Ambassadors, *charges d’affaires*, and other high ranking officers in the armed forces;
- vi. Members of the administrative, management or boards of State-owned corporations.

And where applicable, for the purposes of subparagraphs (i) to (v), shall include positions held at the community or international level;

(b) The term ‘immediate family members’ shall include the following:

- the spouse, or any partner recognised by national law as equivalent to the spouse;
- the children and their spouses or partners; and
- the parents;

(c) the term ‘persons known to be close associates’ shall include the following:

- a natural person known to have joint beneficial ownership of a body corporate or any other form of legal arrangement, or any other close business relations with that politically exposed person;
- a natural person who has sole beneficial ownership of a body corporate or any other form of legal arrangement that is known to have been established for the benefit of that politically exposed person.

We may ask for further documentation as may be deemed necessary e.g. if there is a Trust involved, we will require CDD documents on the Trust, its Trustee, the Protector and the Beneficiaries.</i></p>

"Beneficial Owner" means any natural person or persons who ultimately own or control the customer and, or the natural person or persons on whose behalf a transaction or activity is being conducted, and shall consist of any natural person or persons who ultimately own or control the Client through direct or indirect ownership of twenty-five per centum plus one (1) or more of the shares or more than twenty-five / ten of the voting rights or an ownership interest of more than twenty-five per centum in the Client, including through bearer share holdings, or through control via other means (e.g. trusts, nominee ships etc.)

NB: Please compile 2 copies of each of the above. All certified true copies must read the following **“This document is a true and certified copy of the original which has been seen and verified by the verifier [signed] [occupation] [date]”** and in cases of photographic images (e.g. passports and ID cards) the document must also read **“The photograph is of a true likeness of the individual”**. All due diligence documentation must be in English or translated to English.

- the documents provided herewith are true copies of original.
